In January 2012 the top five companies importing oil from the Persian Gulf were as follows:

1. Exxon Mobil: 14,194,000 barrels

Valero: 12,619,000 barrels
Chevron: 9,243,000 barrels

4. Motiva Enterprises (Shell): 8,942,000 barrels

5. Marathon: 6,080,000 barrels

The U.S. currently imports 5,517,000 barrels of crude oil per day from OPEC. In January 2012, the U.S. imported 119,620,000 barrels of crude oil from OPEC countries (Algeria, Angola, Ecuador, Iraq, Kuwait, Libya, Nigeria, Qatar, Saudi Arabia, United Arab Emirates, and Venezuela). That works out to an average of 3.9 million barrels of crude oil per day.

According to recent figures regarding crude oil imports, in January 2012 only 25% of the USA's crude oil imports came from countries classified by the U.S. Department of Energy (DOE) as Persian Gulf exporters (i.e., Iran, Iraq, Kuwait, Qatar, Saudi Arabia, United Arab Emirates, Bahrain.)
